Resource Definitions:

Web page

A document which can be displayed in a web browser such as Firefox, Google Chrome, Microsoft Internet Explorer or Edge, or Safari. These are also often called "web pages" or just "pages."

All web pages available on the web are reachable through a unique address. To access a page, just type its address in your browser address bar:

Website

A collection of *web pages* which are grouped together and usually connected together in various ways. Often called a "web site" or simply a "site."

A *website* is a collection of linked web pages (plus their associated resources) that share a unique domain name. Each web page of a given website provides explicit links—most of the time in the form of clickable portion of text—that allow the user to move from one page of the website to another.

To access a website, type its domain name in your browser address bar, and the browser will display the website's main web page, or *homepage* (casually referred as "the home"):

Blog

A blog is "a chronologically organised website updated by an individual (or a group of individuals) with entries/posts." In other words, the entries are chronologically posted. It contains periodic posts on a common webpage. These posts are usually, but not always, in reverse chronological order.

Wiki

According to Wikipedia a Wiki is "a website that allows users to add content, as on an Internet forum, but also allows anyone to edit the content." In other words, instead of being a page built only by one person or by a team, it's open to the public. Anyone can edit any page of a Wiki - usually all they have to do is sign in.
